## **SUMMARY ANNUAL REPORT FOR RETIREE MEDICAL PLAN OF THE PLUMBER'S WELFARE FUND, LOCAL 130, U.A.**

This is a summary of the annual report for Retiree Medical Plan of the Plumbers' Welfare Fund, Local 130, U.A., EIN 36-4026252, for the period ended May 31, 2025. The annual report has been filed with the Employee Benefit Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Insurance Information**

The plan has contracts with Humana Insurance Company for certain health claims incurred under the terms of the plan. The total premiums for the Plan Year ending May 31, 2025 were \$988,493.

### **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan was \$59,265,500 as of May 31, 2025, compared to \$62,706,469 as of June 1, 2024. During the period, the plan experienced a decrease in its net assets of \$3,440,969. This decrease included unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$17,874,553 including (but not limited to) participant contributions of \$3,479,586, employer contributions of \$8,731,834, and gain from investments of \$5,644,868.

Plan expenses were \$21,315,522 consisting of \$20,408,398 of benefits paid to participants and beneficiaries and \$907,124 in administrative expenses.

transactions in excess of 5% of plan assets.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report.

The charge to cover the copying costs given above does not include a charge for the copying costs of these portions of the report because these portions are furnished without charge. You also have the legally protected right to examine the annual report at the main office of the plan at 1340 W. Washington Blvd, Chicago, Illinois 60607 and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
