## SUMMARY ANNUAL REPORT FOR RETIREE MEDICAL PLAN OF THE PLUMBERS' WELFARE FUND, LOCAL 130 U.A.

This is a summary of the annual report for Retiree Medical Plan of the Plumbers' Welfare Fund, Local 130, U.A., EIN 36-4026252, for the period ended May 31, 2023. The annual report has been filed with the Employee Benefit Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Insurance Information**

The plan has contracts with Humana, Inc. for certain health claims incurred under the terms of the plan. The total premiums for the plan year ending May 31, 2023 were \$297,036.

#### **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan was \$62,165,881 as of May 31, 2023, compared to \$63,544,828 as of June 1, 2022 During the period, the plan experienced a decrease in its net assets of \$1,378,947. This decrease included unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$14,672,376 including (but not limited to) participant contributions of \$3,283,395, employer contributions of \$10,841,498, and gain from investments of \$547,483.

Plan expenses were \$16,051,323 consisting of \$15,148,426 of benefits paid to participants and beneficiaries, \$168,834 of professional fees, \$79,639 of investment fees, and \$654,424 of other administrative fees.

#### **Paperwork Reduction Act Statement**
